**CM-1026-CI-2022 in RFA-8631-2014 &
CM-581-CI-2022 in RFA-5210-2013**

By this order, Regular First Appeal No.8631 of 2014 and Regular First Appeal No.5210 of 2013, shall stands disposed of.

The appeals filed by the appellants i.e. RFA-8631-2014, and RFA-5210-2013, were disposed of in terms of judgment passed in **Regular First Appeal No.7108 of 2012, titled as “Ram Pal and another Vs. Land Acquisition Collector and others”, decided on 16.09.2015.** The various civil appeals were filed before the Supreme Court including an appeal filed by the appellants herein. The judgment passed by the High Court on 16.09.2015, was set aside while remitting the cases back to the High Court for fresh decision vide order dated 06.12.2017. On receipt of the matter from the Supreme Court, the High Court decided a batch of Regular First Appeals on 16.09.2015, in **Ram Pal and another Vs. Land Acquisition Collector and others, Regular First Appeal No.7108 of 2012 and other connected cases.**

Once again, the matter was taken to the Supreme Court which has now been decided vide judgment dated 14.07.2021, in **Civil Appeal No.2903 of 2021, titled as “Banwari Lal and another Vs. State of Haryana and others”.** Inadvertently, the office did not list the present appeal when the matter was decided by the Court in the second round on 31.05.2019.

The appellants pray for disposal of the appeal in terms of the judgment passed by the Supreme Court in **Civil Appeal No.2903 of 2021, titled as “Banwari Lal and another Vs. State of Haryana and others”, decided on 14.07.2021.** The learned counsel representing the State has no objection, in view thereof, the applications are allowed. The appeals are

taken on board for final disposal.

Main

The learned counsel representing the parties are *ad idem* that the present appeals are required to be disposed of in terms of judgment passed in **Civil Appeal No.2903 of 2021, titled as “Banwari Lal and another Vs. State of Haryana and others”, decided on 14.07.2021.**
