The present petition has been filed seeking issuance of a writ in the nature of certiorari & mandamus directing the respondents to provide security to the petitioner till the completion of Gram Panchayat Elections.

Learned counsel appearing on behalf of the petitioner contends that he is on instructions from the petitioner to contend that he is ready and willing to pay the applicable statutory charges to the State as per policy upon being extended security protection.

The said aspect has also been reiterated in paragraph No.4 of the writ petition which is duly supported by an affidavit. He contends that at this juncture he would be satisfied in case the aforesaid claim of the petitioner is considered by the respondent No.3-Inspector General of Police, Rohtak Range, Rohtak. Further, he submitted that even though the prayer is only for the purpose of providing security till the Gram Panchayat Election to be held on 02.11.2022, however, he shall still deposit the monthly charges for the security so claimed by him.

Notice of motion.

Mr. Vivek Chauhan, Additional A.G., Haryana, who is present in Court today and accepts notice on behalf of the respondents and states that he has no objection in case the respondent `No.3-Inspector General of Police, Rohtak Range, Rohtak is directed to look into the grievance of the petitioner and to pass a reasoned and speaking order after affording an opportunity of hearing to the petitioner, in a time bound manner and in accordance with applicable State policy.

Accordingly, the present petition is disposed of with the consent of the parties and without commenting anything on the merits of the instant case and respondent No.3-Inspector General of Police, Rohtak Range, Rohtak is directed to consider the present petition as a representation and to pass an appropriate order on the grievance espoused by petitioner with respect to his life and liberty and if so deemed necessary provide him with adequate security till completion of Panchayat Election upon payment of the requisite charges for the entire month of the deployment so claimed/awarded by the competent authority.

The needful shall be done expeditiously and preferably within a period of one week from date of receipt of certified copy of the order.

Petition stands disposed of accordingly.
