By this common order, four writ petitions, the details of which have been given in the heading, are being disposed of as all the petitions involve the same question of law on similar facts.

CM-17834-CWP-2022 in CWP-25844-2022

As prayed for, the application is allowed.

CWP-25844 of 2022 and other connected cases

In the present petitions, the grievance of the petitioner(s) is that their claim are being decided by a general order though, a specific show cause notice was issued to all the petitioners, which show cause notice has already been replied for and therefore, without passing the separate order in case of the each employee concerned, the general orders are being relied by the respondents to withdraw a benefit from the petitioner(s), which act on the part of the respondents is totally arbitrary and illegal.

Mr. Harish Nain, Assistant Advocate General, Haryana, who is present in the Court, keeping in view the service of advance copy of petitions, accepts notice on behalf of the respondents.

Learned counsel for the respondents, on the instructions from

Mr. Nar Singh, SA O/o District Education Officer, Hisar, submits that he

has instructions to submit that in regard to the show cause notice which has been issued to the employee or which may be issued in future, separate order will be passed on the claim of each employee on the basis of the show cause notice after considering the reply filed by the employee concerned and no action will be taken on the basis of the general order dated 17.10.2022, without following the above stated procedure.

Learned counsel for the petitioner(s) submits that keeping in view the said, no further grievance of the petitioner(s) survives in the present writ petitions and the same may kindly be disposed of having been not pressed any further.

Ordered accordingly.
