By this order, 20 Civil Revision petitions, mentioned above,
shall stand disposed of.

On 21.11.2022, the following order was passed:-

*“The learned counsel representing the petitioner inter alia contends that without any enforceable decree, order, judgment or award of the competent court, a co-sharer/co-owner is not entitled to file an execution petition. He relies upon the judgment passed by this Court in **Rajender Singh and Another vs. State of Haryana and Others (Civil Revision No.814 of 2020, decided on 15.09.2022).**”*

Let notice of motion to the contesting respondents be issued through their learned counsel in the Executing Court, for 13.12.2022.

Process Dasti only.

In the meantime, the operation and effect of the impugned order shall remain stayed.

A photocopy of this order be placed on the files of each connected case.”

Learned counsels representing the respondents do not dispute that the matter in issue, in all these revision petitions, is identical with the matter decided in **Civil Revision No.814 of 2020 titled as “Rajender Singh and another vs. State of Haryana and others” decided on 15.09.2022.**

Keeping in view the aforesaid position, the orders passed by the Executing Court, in all these revision petitions, are set aside. The revision petitions stand allowed.

All the pending miscellaneous applications, if any, are also disposed of.
