In the present writ petition, it is not a disputed fact that the petitioners were not working with the respondents under outsourced policy but they were working under the private contract. Learned counsel for the petitioners submits that the respondents have abolished the process of employing outsourced employees through private contractor and have created Haryana Kaushal Rozgar Nigam and as per the notification of the Government dated 22.11.2021 (Annexure P/5) details of the contractual/outsourced employees, who are working as such are required to be uploaded with the Haryana Kaushal Rozgar Nigam so that they can be adjusted, wherever vacancies arises.

Learned counsel for the petitioners submits that though, the petitioners have worked with the respondents but their data is not being

uploaded for the reasons best known to the respondents. Prayer of the petitioners is that the respondents be directed to upload the data of the petitioners keeping in view the decision taken by the Government vide notification dated 22.11.2021 (Annexure P/5).

Learned counsel for the petitioners further submits that the petitioners have already raised the said grievance before the respondents by way of filing a representation dated 18.08.2022 (Annexure P/9), which is still pending consideration with the respondents and the petitioners will be satisfied in case a time bound direction is issued to the respondent No.3 to decide the said representation.

Notice of motion.

Mr. Harish Nain, AAG, Haryana, who is present in the Court, accepts notice on behalf of respondent-State and raises no objection in deciding representation dated 18.08.2022 (Annexure P/9) in a time bound manner by passing an appropriate speaking order.

In view of the request made, without expressing any opinion on the merits of the case or the claim being made by the petitioners in their representation dated 18.08.2022 (Annexure P/9), respondent No.3 is directed to decide the representation dated 18.08.2022 (Annexure P/9) by passing a speaking order within a period of 08 weeks from the date of receipt of copy of this order.

Present writ petition stands disposed of.
