1. This batch of appeals, cross-appeals and cross-objections (details whereof are on the foot of the judgment) has been filed by the landowners as well as the State of Haryana with a prayer to modify the awards passed on 06.01.2017, 01.03.2017, 25.05.2017, 19.07.2017, 20.07.2017, 01.08.2017, 03.10.2017, 02.04.2018 and 03.04.2018 by the Reference Court (hereinafter referred to as “the RC”). The notifications under Section 4 and 6 of the Land Acquisition Act, 1894 (hereinafter referred to as “the 1894 Act”) and the awards passed by the Land

the RC are common. The learned counsel representing the respective parties are *ad idem* that these appeals can conveniently be disposed by the same order. Before reserving the judgment, the arguments of learned counsel representing the different landowners were heard on 05.08.2022 and 10.08.2022.

2. The brief particulars, for the purpose of decision of the appeals, are as under:-

		been held entitled to compensation for structure as well as trees.

3. The landowners, while filing the applications under Section 18 of the 1894 Act, claimed that the acquired land was located not only within the municipal limits of Tauru, but all the modern facilities/amenities such as hospitals, high schools, colleges, power stations, commercial and industrial establishment exist. The acquired land is located near the bus stand, grain market and main bazaar, besides being located near Palwal-Sohna-Rewari State Highway. The Industrial Township, Bhiwari is located at a distance of 4-5 kms. from the acquired land, therefore, the market value of the acquired land was not less than ₹5,00,00,000/- per acre on the date of notification under Section 4 of the 1894 Act. Whereas, the respondents contested the claim of the landowners while submitting that the LAC has taken into consideration the relevant material before assessing the market value. The respondent No.3 i.e. Haryana Urban Development Authority (hereinafter referred to as “HUDA”), the beneficiary of the acquisition, adopted the written statement filed by the respondent No.1 and 2 (State of Haryana and the Land Acquisition Collector).

4. On the appreciation of the pleadings, the following issues were culled out:-

- “1)

What was the market value of the acquired land on the date of notification under section 4 of the Land Acquisition Act?OPP
- 2)

Whether the present petitions were filed within the time period as envisaged u/s 18 of the Act? OPR

3) Relief”.

5. In the appeals arising from the LAC’s award dated 06.01.2017, the landowners examined the following witnesses:

6. On the other hand, the State of Haryana has examined RW.1 Kuldeep, Patwari and RW.2 Khajan Singh, Registry Clerk, to prove the collector rates for the years 2010 to 2017.

7. In the RC’s award dated 01.03.2007, the landowners, examined PW.1 Navneet Lal, PW.2 Shakuntla, PW.3 Vinod Kumar, PW.4 Hakam Chand, PW.5 Fateh Chand Bansal in their oral evidence and produced the previous award dated 06.01.2017 in “Chiranji Lal v. State of Haryana”. They also produced the various sale deeds in their documentary evidence. In the RC’s award dated 23.05.2017, the landowners relied upon the assessment made by the RC vide judgment dated 06.01.2017, whereas, the State did not produce any evidence.

8. In RC's award dated 19.07.2017, the landowners relied upon its previous award dated 06.01.2017 in "Chiranji Lal's case (supra), whereas the government counsel admitted that the issue is covered by the said judgment.

9. In RC's award dated 20.07.2017, the landowners examined PW.1 Des Raj, PW.2 Sirajudin, PW.3 Suresh Kumar, Halqa Patwari, PW.4 Madan Lal, Draftsman, Municipal Committee, Tauru, whereas, the State did not produce any oral evidence. The landowners produced the various documents, which shall be discussed in the later part of the judgment.

10. In the RC's award dated 01.08.2017, the landowners, once again, relied upon the judgment in "Chiranji Lal's case (supra) dated 06.01.2017, whereas, the State did not produce any evidence.

11. In the RC's award dated 03.10.2017, in order to prove their case, the landowners produced the judgments passed by the RC on 06.01.2017 (Chiranji Lal v. State of Haryana) and dated 01.03.2007 (Sri Bhagwan v. State of Haryana). On the other hand, the HSIIDC examined Uma Shankar, Patwari of the area.

12. In the RC's award dated 02.04.2008, the landowners did not lead any oral evidence but produced copies of the judgments dated 01.03.2017 (Sri Bhagwan v. State of Haryana) and 06.01.2017 (Chiranji Lal v. State of Haryana) as Ex.P1 and Ex.P2, respectively. Per contra, the State has examined Uma Shankar, Patwari.

13. In the RC's award dated 03.04.2018, the landowners produced copy of the judgment dated 06.01.2017 (Chiranji Lal v. State of Haryana), whereas, the HSIIDC examined Uma Shankar, Patwari of the area.

Note: The same sale deeds have been assigned different exhibit numbers by the RC in different cases. Thus, for the sake of clarity, the sale deeds as exhibited in the record of RC’s award dated 06.01.2017 have been compiled in the table above.

15. It would be appropriate to briefly notice the reasons recorded by the RC while passing the impugned judgments. The RC, after refusing to rely upon the sale instances Ex.P2 to Ex.P10 on the ground that these sale instances are of small pieces of land, relies upon the sale instance (Ex.P76) pertaining to 66 kanals of land dated 04.07.2011. Thereafter, the RC applied a development cut @ 25% while assessing the market value of the acquired land @ ₹92,62,500/- per acre. The RC has excluded the sale instances produced by the State (Ex.RW.1/C to Ex.RW.1/H) on the premise that the sale consideration is less than the market value of the acquired assessed by the LAC and the Court is debarred from taking such sale deed into consideration while assessing the market value of the acquired land. In support thereof, the RC relied upon a Division Bench Judgment in **Dr.P.S.Verma Vs. State of Haryana 2005 (10) RCR (Civil) 677**. The RC has also refused to take into consideration the collectors rate for the years 2010-2011 and 2015-2016 being irrelevant. While assessing the compensation for structure and the trees, the RC relied upon the report of the

16. Heard the learned counsel representing the parties and with their able assistance, perused the paper-book along with the record of the RC which was requisitioned as well as the written notes of arguments filed by various counsels.

17. The learned counsel representing the landowners contend that even the State of Haryana has relied upon the sale instances of small pieces of the land and that also with respect to the period post the notification under Section 4 of the 1894 Act. While projecting that the major part of the acquired land is located in the municipal limits, they submit that the sale instances of the small pieces of land should be relied upon after applying discount of 10-20% and the sale instances (Ex.P2, Ex.P8 and Ex.P10) are located in and around the acquired land or in its immediate vicinity, therefore, the same can be relied upon for assessing the market value. In the alternative, the learned counsel contend that the RC has wrongly applied deduction of 25% on the price of the sale deed (Ex.P7), though, the parcel of land is exactly of the same nature and characteristics when compared with the acquired land. They submit that the location of the land governed by the sale instance (Ex.P76) is at distance of 5 acres from the acquired land.

18. On the other hand, the learned counsel representing the State of Haryana, while drawing the attention of the Court to the layout plan (Ex.RW.1/R and Ex.RW.1/S) contends that the sale instances produced by the State of Haryana, particularly Ex.RW.1/D, Ex.RW.1/E, Ex.RW.1/F and Ex.RW.1/H prove that the market value of the acquired land has been correctly assessed by the LAC. While highlighting, the learned counsel contends that the sale instance (Ex.RW.1/D, Ex.RW.1/E, Ex.RW.1/F and

Ex.RW.1/H) are the sale instances of the parcels of the land out of the land comprised in rectangle No. 57 and 118, respectively, while some part of the acquired land also comprised of the land of aforesaid rectangle.

19. The landowners have produced the various layout plans including Ex.P1. It is evident that there are two roads going from the area of small town Tauru. The first is Rewari-Sohna road which is stated to be a State Highway. Whereas the other road is going from Pataudi to Nuh. The acquired land is in two separate independent parcels. The sale instance (Ex.P76) is with respect to the purchase of commercial land on Nuh-Pataudi road. The land has been purchased by M/s Gokal Dass Warehousing Corporation, obviously for the commercial purpose.

20. From the careful study of the layout plans (Ex.RW.1/R and Ex.RW.1/S) along with the sale deeds produced by the State of Haryana, it is evident that the sale instances (Ex.RW.1/D) is with respect to the land comprised in rectangle No. 57 and 119. Some part of the land comprised in rectangle No.57 has also been acquired in the present acquisition. Similarly, a small parcel of the land comprised in rectangle No. 118 has also been acquired, whereas, the sale exemplar Ex.RW.1/E is also with respect to the land comprised in same rectangle. Similar is the position with regard to the sale deeds (Ex.RW.1/F and Ex.RW.1/H).

21. No doubt, the sale instances produced by the State are post the date of notification under Section 4 of the 1894 Act, however, these sale instances give us some guidance about the market value of the acquired land on the crucial date i.e. 11.02.2011. The RC has correctly held that the sale instances (Ex.P2 to Ex.P8) are with respect to a very small pieces of land

and hence, not found appropriate or worth reliance to assess the market value of the acquired land particularly when other sale exemplars have been produced. Ex.P9 is also post the date of notification under Section 4 of the 1894 Act.

22. As already discussed, Ex.P76 is not only with respect to the commercial piece of land located on Nuh-Pataudi road but also five months after the date on which notification under Section 4 of the 1894 Act was issued. In other words, after the State of Haryana proposed acquisition in the area in order to develop the residential and commercial sectors, a company purchased 66 kanals of commercial land on Nuh-Pataudi road in order to take benefit of the residential and commercial sectors already planned to be developed by the State of Haryana. Hence, the RC has wrongly relied upon the sale instance (Ex.P76).

23. In terms of the agricultural land, the expression “rectangle” denotes a compact parcel of land comprised of 25 acres (5x5 acres). In Northern India, at the time of consolidation of holdings, the land of the village was divided into rectangles, killa/khasra numbers, kanals and marlas.

A glossary of the words is extracted as under:-

24. Now, this Bench examines the arguments of the learned counsel for the parties. Through first argument, the learned counsel contends that the sale instances of the small pieces of land should be relied upon. In the absence of any other evidence, the Court can rely upon such parcels of the sale instances. However, in the present case, the State has produced the sale instance (Ex.RW.1/D and Ex.RW.1/F) of the sufficiently large area representing 1½ acres of land (12 kanals), which is even post the date of notification under Section 4 of the 1894 Act. The land measuring 12 kanals of land was sold @ ₹40,00,000/- per acre only and both the parcels namely Ex.RW.1/E and Ex.RW.1/F are part of the land comprised in rectangle No. 57, which has partially been acquired. Hence, the sale instances represented by Ex.P1 to Ex.P8 and Ex.P10 cannot be relied upon particularly when all the sale instances are of tiny plots of few marlas of land. Ex.P3 is a sale instance of the land measuring 1 kanal and 10.5 marlas only, which again is not likely to be used for agricultural purposes as the total area of land comes to 920 square yards approximately, whereas an acre of land ordinarily consists of 4840 square yards.

25. Through the next argument, the learned counsel calls upon the Court to take the average of the price reflected in the sale deeds (Ex.P2 to Ex.P8 and Ex.P10) which are alleged to have been situated in and around the acquired land. It is well settled that while assessing the market value of the acquired land, the Court is to look for comparable sale exemplars of contemporaneous period. Once Ex.P2 to Ex.P8 and Ex.P10 are not

comparable, therefore it would not be appropriate to take the average price of the sale deeds for the purpose of assessing market value of the acquired land.

26. In the alternative, the learned counsel submits that the sale instance (Ex.P76) represents the land of same nature and characteristics as is that of the acquired land. It would be noted here that after the sector has been planned and notified, a private company has purchased a large chunk of land through the sale deed (Ex.P76) on Nuh-Pataudi Road. This sale instance is post the date of notification under Section 4 of the 1894 Act. The market value of the acquired land is required to be determined on 11.02.2011. Hence, it would not be appropriate to rely upon the sale deed (Ex.P76).

27. Now, let us analyze the reasons recorded by the RC, though, most of the area has already been covered. With regard to the sale deed (Ex.P76), the Court has already discussed the matter. Hence, need no further elaboration. The RC erred in refusing to take into consideration the sale instances (Ex.RW.1/C to Ex.RW.1/H) on the ground that the amount of sale consideration is less than the market value of the acquired land assessed by the LAC while relying upon a Division Bench judgment passed in ***Dr. P.S.Verma's case (supra)***. With highest respect, the judgment of the Division Bench is not based on correct interpretation of Section 25 of the 1894 Act which does not debar the Court from taking into account the various sale instances reflecting the price lower than the amount assessed by the LAC. It only prohibits the Court from awarding the market value to the landowners lower than the amount assessed by the LAC. This matter is no longer res

integra in view of the judgment passed by the Supreme Court in ***Lal Chand vs. Union of India, (2009) 15 SCC 769***. Hence, the judgment passed by the Division Bench in ***Dr. P.S.Verma's case (supra)*** is no longer a good law.

28. The next reason assigned by the Court while refusing to rely upon the Collector's rate is correct and hence, need no elaboration. The Collector's rates are only for the guidance of the Registrar or Sub Registrar for directing the vendor to affix/pay appropriate stamp duty at the time of execution of transfer deeds.

29. As regards the assessment made by the RC with respect to the market value of the structures as well as the trees, though learned counsel has made submissions, however, he failed to put forth any convincing arguments in this respect.

30. It is significant to note that the RC while assessing the market value of the acquired land is required to examine the case in a pragmatic manner while taking a holistic view of the matter. It is expected from the Court to come to a correct conclusion on critical analysis of the evidence produced before it. Before enhancing the market value, the Court must have some definite evidence which proves that the assessment made by the LAC is erroneous or the various sale instances of the comparable parcels of the land in the contemporaneous period have been ignored. In the absence thereof, the Court should not proceed to enhance the market value of the acquired land.

31. Keeping in view the aforesaid facts, it is evident that the landowners have failed to draw the attention of the Court to any material

regard to the market value of the acquired land. Consequently, the appeals/cross-objections filed by the land owners are dismissed, whereas, the cross-appeals/cross-objections filed by the State of Haryana are allowed. All the reference applications, filed by the landowners under Section 18 of the 1894 Act, shall stand dismissed except the amount assessed for structures and trees.

32. The miscellaneous application(s) pending, if any, in all the appeals, shall stand disposed of.
