SANJAY VASHISTH, J. (Oral)

In pursuance to order dated 29.11.2022, warrant officer was appointed, who went over the spot, and got detenue released. Report dated 07.12.2022 prepared by the warrant officer is reproduced hereinbelow:-

“For carrying out the order dated 29.11.2022 passed by Hon'ble Court, I have been appointed as warrant officer in the above noted case. I alongwith petitioner proceeded for Police Station, Talwandi Bhai, District Ferozepur and reached there at 1:15 A.M, dated 30.11.2022. We entered. in the Police Station where Jaspal Singh, ASI was on night duty. I disclosed my identity and demanded force to search Pawandeep Kaur. ASI called lady constable Rajwinder Kaur who came in the Police Station after 30-35 minutes. Then computer operator typed GD No. 4 dated 30.11.2022, 2: 04 hrs which is at Flag ‘A’ After that with the help of ASI Jaspal Singh and Police party we reached Surinder Singh's house at Village Kot Karor Kalan. ASI knocked the door of the house. Surinder Singh Father of detenue opened the door. I disclosed my identity to him and asked about Pawandeep Kaur. Surinder Singh called Pawandeep Kaur. She met us. I asked her name. She said I am Pawandeep Kaur and my parents have forcibly going to marry me with some young boy which is not suitable to me and on my refusal my parents snatched my passport, I-Phone and watch. When I asked her whether you want to stay here or want to go with us at some safe place. She replied that

she want to go with us, then her parents started quarreling with her. On this she went in side and bring a big bag containing her articles. In the mean time her cousin Mandeep Singh @ Gora said that her passport had been burnt and I don't know regarding remaining other articles.

Then I got served notices to Resp. No. 4 and 5, Surinder Singh and Karamjeet Kaur. Then I came back to the Police Station Talwandi Bhai where computer operator typed GD No. 5 dated 30.11.2022, 3:54 Hrs which is at Flag 'B'. I received both the DDR and I also got served notices of respondent no. 2 and 3 through Munshi.

After receiving all the documents we came out from the Police Station alongwith Pawandeep Kaur. I also obtain a statement of Pawandeep Kaur which is at Flag 'C' for kind perusal. We dropped her in sector 71, Mohali and petitioner dropped me at my residence, Chandigarh."

Mr. Gurmeet Singh, Advocate, who appears in-person, submits that thereafter, detenue has left to Australia on 21.12.2022, and nothing is left to be decided in the present petition. He seeks withdrawal of the present petition.

Dismissed as withdrawn.
