In the present petition, the prayer of the petitioner is that for considering his claim for the grant of promotion keeping in view the provisions of Persons with Disabilities (Equal Opportunities, Protection of Rights and Full Participation) Act, 1995 (hereinafter referred as '1995 Act') as well as the judgment of the Hon'ble Supreme Court of India in ***Union of India and another vs. National Federation of the Blind and others, 2013 (1) SCC 772.***

After notice of motion, the respondents have filed the reply wherein, the respondents have stated that the claim of the petitioner for the grant of promotion is under consideration.

Learned counsel for the respondents, even today, submits that the claim of the petitioner is still under consideration though, the reply was filed on 03.12.2019 and more than two and half years have passed after the filing of the reply.

Learned counsel for the respondents further submits that the consideration will be taken to the logical end as expeditiously as possible.

Learned counsel for the petitioner submits that delay in deciding the claim of the petitioner is causing prejudice to him everyday, hence, the respondents be bound to finalize the consideration with regard to the claim of the petitioner in a time bound manner.

Keeping in view the above, the present petition is disposed of with a direction to the respondents to finalize the consideration of the claim of the petitioner seeking promotion keeping in view 1995 Act coupled with the decision of the Hon'ble Supreme Court of India in ***Union of India's case (supra)*** as well as the instructions which have been issued by the

Government of Haryana including instructions dated 25.03.2022 within a period of two months from the receipt of copy of this order.

As the main writ petition is disposed of, application i.e. CM-4281-CWP-2022 also stands disposed of.
