VINOD S. BHARDWAJ. J. (ORAL)

By means of the instant petition, the jurisdiction of this Court under Section 482 of the Code of Criminal Procedure has been invoked for seeking quashing of FIR No.305 dated 21.10.2017 under Sections 148, 149, 323, 325, 34, 379-A and 506 of the Indian Penal Code, 1860 registered at Police Station Pinjore, Panchkula and all other consequential proceedings arising therefrom, on the basis of compromise dated 22.10.2019 (Annexure P-2) entered between the parties.

2 The parties were directed to appear before the learned trial Court/Illaq Magistrate vide order dated 15.03.2022 of this Court, to get their statements recorded regarding the compromise arrived at between the parties and a report in this regard was called for.

3. Pursuant to the said order, report has been received from the Judicial Magistrate First Class, Kalka vide Memo No.192 dated 06.04.2022. The relevant extract of the report is reproduced as under:-

The complainant-Ajay Sharma and another injured Vikramjeet Sharma has suffered a separate statement to this effect that they have entered into compromise with the accused persons in case FIR No.305 dated 21.10.2017 under Sections 148, 149, 323, 325, 34 & 506 of IPC with the intervention of the respectable persons of society and there is no dispute between them. They have no objection if on the basis of compromise the present FIR is quashed and in present FIR Jitender, Jarnail, Gurdhayan Singh and Parabdeep Singh are only accused & no other accused. Further stated that they have compromised the matter with accused without any pressure and undue influence. Thereafter, joint statement of accused namely Jitender, Jarnail, Gurdhayan Singh and Parabdeep Singh were recorded to this effect that in present FIR they are only four accused & no other person is accused. They have never been declared Proclaimed Offender by any Hon'ble court. They entered into compromise with the complainant & injured out of our free-will and without any pressure or coercion. Statement of both the parties recorded separately.

It is submitted that after going through the statement made by the complainant, injured and accused persons, this court is satisfied that the statements regarding the compromise is made by them out of their own free-will and without any fear, threat or coercion from any side. The compromise also appears to be voluntarily in nature. Present case is pending for arguments on application under Section 319 Cr.P.C.

4. Learned State counsel does not dispute the factum of the compromise amongst the parties and does not have any serious objection to the resolution of the dispute amongst the parties.

5. Mr. Ashish Sanghi, Advocate appears on behalf of respondent Nos.2 and 3 and reiterates the settlement and his concurrence to the FIR and all the other consequential proceedings being quashed.

6. The Full Bench of this Court in the matter of “**Kulwinder Singh and others versus State of Punjab and another**” reported as (**Punjab and Haryana High Court**) : 2007 (3) RCR (Criminal) 1052 has observed as under:

'(28) To conclude, it can safely be said that there can never be any hard and fast category which can be prescribed to enable the Court to exercise its power under Section 482 of the Cr.P.C. The only principle that can be laid down is the one which has been incorporated in the Section itself, i.e., "to prevent abuse of the process of any Court" or "to secure the ends of justice".

(29) In Mrs. Shakuntala Sawhney v. Mrs. Kaushalya Sawhney and Ors., Hon'ble Krishna Iyer, J. aptly summoned up the essence of compromise in the following words:

“The finest hour of justice arrives propitiously when parties, despite falling apart, bury the hatchet and weave a sense of fellowship of reunion.”

(30) The power to do complete justice is the very essence of every judicial justice dispensation system. It cannot be diluted by distorted perceptions and is not a slave to anything, except to the caution and circumspection, the standards of which the Court sets before it, in exercise of such plenary and unfettered power inherently vested in it while donning the cloak of compassion to achieve the ends of justice.

(31) No embargo, be in the shape of Section 320(9) of the Cr.P.C., or any other such curtailment, can whittle down the power under Section 482 of the Cr.P.C.

(32) The compromise, in a modern society, is the sine qua non of harmony and orderly behaviour. It is the soul of justice and if the power under Section 482 of the Cr.P.C. is used to enhance such a compromise which, in turn, enhances the social amity and reduces

friction, then it truly is "finest hour of justice". Disputes which have their genesis in a matrimonial discord, landlord-tenant matters, commercial transactions and other such matters can safely be dealt with by the Court by exercising its powers under Section 482 of the Cr.P.C. in the event of a compromise, but this is not to say that the power is limited to such cases. There can never be any such rigid rule to prescribe the exercise of such power, especially in the absence of any premonitions to forecast and predict eventualities which the cause of justice may throw up during the course of a litigation.

(33) The only inevitable conclusion from the above discussion is that there is no statutory bar under the Cr.P.C. which can affect the inherent power of this Court under Section 482. Further, the same cannot be limited to matrimonial cases alone and the Court has the wide power to quash the proceedings even in non-compoundable offences notwithstanding the bar under Section 320 of the Cr.P.C., in order to prevent the abuse of law and to secure the ends of justice.

(34) The power under Section 482 of the Cr.P.C. is to be exercised Ex-Debitia Justitia to prevent an abuse of process of Court. There can neither be an exhaustive list nor the defined para-meters to enable a High Court to invoke or exercise its inherent powers. It will always depend upon the facts and circumstances of each case. The power under Section 482 of the Cr.P.C. has no limits. However, the High Court will exercise it sparingly and with utmost care and caution. The exercise of power has to be with circumspection and restraint. The Court is a vital and an extra-ordinary effective instrument to maintain and control social order. The Courts play role of paramount importance in achieving peace, harmony and ever-lasting congeniality in society. Resolution of a dispute by way of a compromise between two warring groups, therefore, should attract the immediate and prompt attention of a Court which should endeavour to give full effect to the same unless such compromise is abhorrent to lawful composition of the society or would promote savagery.

7. The legal principles as laid down for quashing of the judgment were also approved by the Hon'ble Supreme Court in the matter of '**Gian Singh Versus State of Punjab and another,(2012) 10 SCC 303'**. Furthermore, the broad principles for exercising the powers under Section 482 were summarized by the Hon'ble Supreme Court in the matter of '**Parbatbhai Aahir (@ Parbatbhai Bhimsinhbhai Karmur and others versus State of Gujarat and another"**' (2017) **9 SCC 641'**.

8. It is evident that in view of the amicable resolution of the issues amongst the parties, no useful purpose would be served by continuation of the proceedings. The furtherance of the proceedings is likely to be a waste of judicial time and there appears to be no chances of conviction.

9. The Hon'ble Supreme Court has held in the matter of '**Ramgopal And Another Vs State of Madhya Pradesh, 2021 SCC Online SC 834'**, that the matters which can be categorized as personal in nature or in the matter in which the nature of injuries do not exhibit mental depravity or commission of an offence of such a serious nature that quashing of which would override public interest, the Court can quash the FIR in view of the settlement arrived at amongst the parties. The observation of the Hon'ble Supreme Court is extracted as under:-

19. We thus sum-up and hold that as opposed to Section 320 Cr.P.C. where the Court is squarely guided by the compromise between the parties in respect of offences 'compoundable' within the statutory framework, the extra-ordinary power enjoined upon a High Court under Section 482 Cr.P.C. or vested in this Court under Article 142 of the Constitution, can be invoked beyond the metes and bounds of Section 320 Cr.P.C. Nonetheless, we reiterate that such powers of wide amplitude ought to be exercised carefully in the context of quashing criminal proceedings, bearing in mind: (i) Nature and effect

of the offence on the conscience of the society; (ii) Seriousness of the injury, if any; (iii) Voluntary nature of compromise between the accused and the victim; & (iv) Conduct of the accused persons, prior to and after the occurrence of the purported offence and/or other relevant considerations.

10. The following relevant factors emerge from perusal of the case as well as the subsequent developments supplementing a case for invocation of the powers under Section 482 CrPC:-

- i. The dispute in question arose on account of the complainant representing the opposite party as an advocate. The incident in question happened at the spur of the moment and without any pre-meditation;
- ii. The offence under Section 379-A, which was initially incorporated in the FIR, stands deleted during the course of investigation and does not exist any further;
- iii. The petitioners are in their late 20s and early 30s and continued incarceration in criminal proceedings is likely to impact their future prospects;
- iv. The FIR in question was registered in the year 2017, yet as per the report received from the Judicial Magistrate First Class, Kalka, the case is fixed for arguments on an application under Section 319 CrPC, hence, the case is still at the initial stage;
- v. The offence in question cannot be said to be heinous or as an offence that would be shocking to the conscience of the society or public at large. It can also not be termed as one shocking to the conscience of the Court;
- vi. Continuation of the proceedings and forcing the parties to undergo rigours of criminal proceedings is not likely to sub-serve any large public interest;
- vii. The complainant is not likely to support the case of the prosecution.

Continuation of the proceedings is likely to be a waste of judicial time. The proceedings are likely to end in futility for want of parties to support the case of the prosecution;

viii.No larger public purpose would be served by continuation of the proceedings;

ix. The object of law is well served when the parties resolve their differences and choose to peacefully co-exist and live in harmony.

11. In view of the report of the Judicial Magistrate First Class, Kalka and the principles laid down by the Apex Court in *Gian Singh Vs. State of Punjab and others (2012) 10 SCC 303*, as well as *Ramgopal And Another Vs State of Madhya Pradesh 2021 SCC Online SC 834* and also by the Full Bench of this Court in *Kulwinder Singh and others Vs. State of Punjab and another, 2007(3) RCR (Criminal) 1052*, the instant petition is allowed. The aforesaid FIR No.305 dated 21.10.2017 under Sections 148, 149, 323, 325, 34, 379-A and 506 of the Indian Penal Code, 1860 registered at Police Station Pinjore, Panchkula and all other consequential proceedings arising therefrom, **are hereby quashed** qua the petitioners in view of compromise dated 22.10.2019 (Annexure P-2). However, the same would be subject to payment of costs of Rs.10,000/- to be deposited by the petitioners with the **Poor Patients Welfare Fund at PGIMER Chandigarh** within one month from receipt of certified copy of this order.

Petition is allowed.
