Instant petition has been filed under Section 482 of Cr.P.C. for issuance of a direction to respondent No.2 to re-investigate the complaints submitted by the petitioner against private respondents and to hand over the investigation of the case to any other investigating agency.

On a direction passed by this Court, State has filed an affidavit of Deputy Superintendent of Police, CAW & CC, District Hoshiarpur on behalf of official respondents No.1 and 2, which is taken on record, wherein it has been submitted as under:-

“6. That it is submitted that the Police of P.S. Women Cell Garhshankar, Camp at Chabbewal verified from the Incharge of P.C. Branch of Office of SSP, Hoshiarpur with regard to the application Annexure P-3 of the Petition (sic petitioner), dated 15.10.2019 and the Incharge P.C. Branch, Hoshiarpur specifically gave in writing that the office of SSP, Hoshiarpur did not receive any application dated 15-10-2019 submitted by petitioner

or her daughter Amandeep Kaur Jaura. However, the deponent got conducted the inquiry of application dated 15.10.209 (sic 2019) (Annexure P-3 of the Petition) from In-charge Women Cell Garshankar Camp at Chabbewal Distt Hoshiarpur. During the inquiry of the said application (Annexure P-3 of the Petition), the Petitioner neither joined the inquiry despite repeated notices sent by the Incharge women Cell Garshankar Camp at Chabbewal Distt Hoshiarpur for joining the inquiry nor produced any evidence to prove allegations levelled by her in her above-mentioned application. Despite repeated requests by the police authorities, the Petitioner did not join the investigation nor did she produce any supporting material to substantiate her assertions. The Petitioner further has not submitted any fresh material before the police authorities that corroborates the submissions made by her vide Annexure P-3 of the Petition. However, after due process, the application i.e. Annexure P-3 of the petition (sic petitioner), has been duly perused and inquired into, and thereafter on account of the above described facts and circumstances, the same has been recommended to be filed by the SSP Hoshiarpur.”

In view of the above affidavit, nothing survives in the petition,
which is hereby dismissed.
