**ARUN MONGA, J. (ORAL)**

Vide this common order, bunch of above-mentioned writ petitions are being disposed of, since not only the facts but the law points and the issues raised therein are also similar. For brevity, recitals are taken from CWP No.11474 of 2018.

2. Petition herein, *inter alia*, is for issuance of appropriate writ commanding the respondents to consider candidatures of the petitioners for the post of Multi Purpose Health Workers (Male) for Health Services Haryana against Advertisement No.1 of 2015, Category No.7, dated 19.06.2015 (Annexure P-1). Further, a writ in the nature of Mandamus has been sought directing respondents to consider the claim of the petitioners according to their merit.

3. On 22.03.2022, after hearing learned counsels, following order was passed by this Court:-

*“Learned State counsel relies on Annexure R3/1 filed along with his written statement in response to CWP No.11474 of 2018. However, perusal of the said document reveals that it has been collectively appended and serial number of the candidates are randomly put and the same are not in seriatim as it ought to have been.*

*Learned State counsel seeks time to file correct copy thereof.*

*Post it on 12.07.2022.*

*In case any further return is required to be filed in any of the bunch of these petitions, needful be done on or before the next date of hearing failing which arguments will be heard on the basis of pleadings already filed in the lead case.*

*Meanwhile in the larger interest of maintaining transparency and to obviate any heartburn amongst candidates with respect to their apprehension that despite having more marks they have not been selected, respondent No.1- Commission is directed to upload the result of all the petitioners as well as of the successful candidates on the website so that the petitioners can compare their marks vis-a-vis the selected candidates.*

*Let the needful be done within a period of 30 days from today.*

*Photocopy of this order be placed on the connected case files.”*

4. *Apropos*, learned State counsel submits that result of all the successful candidates, including unsuccessful petitioners before this Court, has been uploaded on the website. He has also tendered a comprehensive additional short reply dated 31.08.2022 on behalf of respondent No.3 in course of hearing, which is taken on record. Under instructions from Mr. Sandeep Manda, ADA and Mr. Jagdeep, Law Officer, Haryana Staff Selection Commission, he states that even if petitioners are held to be eligible for applying to the post in question, none of them have got more marks than the last selected candidates in the respective categories they have applied. Some of the learned counsel for the petitioners seriously controvert aforesaid statement of the learned state counsel. Per contra, they submit that despite having more marks than the last selected candidate in the category in which the petitioners had applied, they have not been given benefit thereof, ostensibly, on the ground of being ineligible.

5. Being so, it is considered appropriate that those of the petitioners, who claim that they have got more marks than the last selected candidates in the categories they have applied, provided, it is so as per result uploaded on the website, they are at liberty to approach the respondent-Commission with individual representations. The Commission shall then pass speaking orders giving reasons as to why; (a). they have been held ineligible and; (b). whether or not they actually secured more marks as claimed by them.

6. Needful be done within a period of 60 days of the representation(s) being filed by those of the petitioners, who may choose to do so.

7. Disposed of, accordingly.

8. Pending application(s), if any, including application(s) for impleadment, shall also stand disposed of. CM-10437-CWP-2022 in CWP-25743-2021 seeking segregation from the bunch also stands disposed of as infructuous.
