DINESH KUMAR SHARMA, J. (Oral)

1. This is a transfer petition filed for transfer of the case bearing number HMA/1032/2020 titled as *Dr. Sh. Subodh Kumar vs. Shakuntala Chahar @ Jyoti* under section 13(1) (ia) & (ib) of Hindu Marriage Act, 1955 and GP/68/2019 titled as *Dr. Sh.
