writ/writs, order/orders,
direction/directions in the nature of*



Mandamus for direction the Respondents for vacating the encroachment from the gairmajarua land bearing Plot No. 516/1 (Khata No. 133) under the Village of Manikpur (Thana No. 149), Anchal Harsiddhi, District- East Champaran.

(ii) For direction to the Respondent 1st Set for measurement to the aforesaid Khata No. 133, Plot No. 516/1, under Village of Manikpur, Anchal- Harsiddhi, District-East Champaran.

(iii) For direction to the respondent 1st set for discharging duty as proper regarding removal of encroachment from the village road."

2. At the outset, the learned counsel for the petitioner seeks not to press the present writ petition, however, seeks liberty on behalf of the petitioner to avail such other alternative remedies, as are otherwise available under the law, including that of filing a suit before the Ld. Civil Court having



competent jurisdiction, for redressal of the
aforesaid grievances. Liberty, so sought, is
granted.

pressed.
