seeking the following relief:-

*“1. That the present writ application is
being filed for issuing a direction to the
respondents specially respondent no.2 to
take necessary action to vacate the*



encroachment made by the private respondent nos. 3 to 10 over the plot nos. 889, 8891, 897, 900, 1020, 924, 938, 974, 977, 981, 1133, 1136, 1187, 1206, 1210, 1212 pertaining to Khata No. 58 and Plot No. 1200 pertaining to Khata No.6 and Plot No. 960, 961, 962, pertaining to Khata No.9 and Plot No. 978, 980 of pertaining to Khata No.57 of Village-Dhanaho, P.S.- Singhiya, Thana No. 191 of District-Samastipur."

At the outset, the learned counsel for the petitioner seeks liberty on behalf of the petitioner to approach the Circle Officer, Singhiya, District-Samastipur, for redressal of his aforesaid grievance. Liberty so sought is granted.

It is needless to state that in case the petitioner approaches the Circle Officer, Singhiya District-Samastipur, by filing appropriate petition under the provisions of the Bihar Public Land Encroachment Act, 1956, within a period of four weeks from today, the same shall be considered, in accordance with law and after hearing the affected parties, appropriate orders shall be passed



thereon, forthwith.

The writ petition stands disposed off on the
aforesaid terms.
