His grievance has been rejected only on 16.12.2015 and certain payments have been made to the petitioner on 29.01.2023. There are certain disputed issues. Petitioner is at liberty to question the validity of order dated 16.12.2015 and so



also disputed amount, if any. Taking note of the inaction in not taking timely action on behalf of respondents it is a case for imposition of cost. The cost is quantified as Rs. 20,000/-. The cost shall be paid to the petitioner within a period of four weeks from the date of receipt of this order.

2. Accordingly, the present M.J.C. stands dropped.
