Considering the prayer made on behalf of the petitioner, seeking quashing of the order passed by the learned S.D.M., Kharagpur, Munger in Case No.406 of 2019, order dated 10.12.2019, under Section 133 of Cr.P.C., this Court is of the opinion is that the present writ application under Article 226 of the Constitution of India is not maintainable.
