2 20-06-2023 The petitioner seeks a direction to the respondent no.6 i.e. the Executive Officer, Nagar Parishad, Danapur, Patna to consider her representation as contained in Annexure- '5' to the writ application. By submitting this representation to the Secretary-cum-Executive Officer, Nagar Teacher Employment Unit, Nagar Parishad, Danapur, the petitioner has requested him to take a decision towards payment of her wages/salary for the period 25.11.2019 to 05.10.2021 considering the order passed



by the District Programme Officer (Establishment), Patna in Memo No.6221 dated 30.09.2021.

Learned counsel for the petitioner submits that the representation, as contained in Annexure- '5', has remained pending for over one year.

In the nature of the grievance raised by the petitioner, this Court grants the petitioner a liberty to approach the Secretary-cum-Executive Officer, Nagar Teacher Employment Unit, Nagar Parishad, Danapur with a copy of this order together with a fresh representation within a period of thirty (30) days from today which will be considered by the Secretary-cum-Executive Officer, Nagar Teacher Employment Unit, Nagar Parishad, Danapur and a decision thereon shall be communicated to the petitioner within a period of two months from the date of receipt of the representation.

This writ application stands disposed of accordingly.
