ORAL ORDER

2 12-04-2023 Heard learned counsel for the petitioner and learned counsel for the State.

The petitioner has filed the present Cr. Writ Petition seeking direction from the Court that fair and impartial investigation may takes place in connection with Shastri Nagar P.S. Case No. 441 of 2022 lodged under Sections 302, 120(B) of the I.P.C. dated 25.07.2022 and also to constitute a Special Investigating Team.
