2 26-04-2023 Learned counsel for the petitioner submits that the petitioner has moved this Court challenging the proposal of selection of respondent no. 9 on the post of Aganwadi Sevika. It is stated that respondent no. 9 has already been selected.

Learned counsel for the State submits that under the 2019 guidelines for the selection of Sevika/Sahayika, the
