Counsel for the petitioner has filed the present
application to set-aside the order dated 06.12.2012 passed by
Deputy Collector Land Reform, Forbesganj in connection with
B.L.D. Case No.95 of 2012-13 and order dated 13.03.2014
passed by Divisional Commissioner, Purnea in B.L.D. Appeal

No.127 of 2013.

Counsel for the petitioner submits that at the time of filing the writ petition the Bihar Land Tribunal was not functional but it is functional now.

Counsel for the State submits that the dispute is relating to the Schedule Act as mentioned under Section 9 of the Bihar Land Tribunal Act, 2009 (Bihar Act 9 of 2009).
