The petitioner shall represent the entire matter before the Superintendent of Police, Siwan within four weeks and the Superintendent of Police, Siwan upon hearing the parties, shall take appropriate decision in the light of representation made by the above said case i.e. ***Surendra Singh Vs. State of Bihar & Ors.*** passed in ***Cr. W.J.C. No. 153 of 2017*** with analogous

cases, with regard to the reliefs.
