The instant appeal has been filed by the

appellant against the order dated 17.11.2022 passed by

learned Additional Sessions Judge-I, Banka whereby the

prayer for bail of the appellant in connection with

Amarpur P.S. Case no. 461 of 2022 under Sections 147,

148, 149, 341, 342, 323, 302 and 504 of the Indian

Penal Code, Section 27 of the Arms Act and sections

3(1)(r)(ss), 3(2)(v) of SC/ST Act was rejected.

As per allegation in the FIR, several accused



persons surrounded the informant's son and on the order of Bishnudeo Yadav, accused Pintu Yadav opened fire. The appellant Pankaj Yadav, Shankar Yadav and Nirdosh Yadav also opened fire. It is further alleged that other accused persons tossed him on floor and started brick batting upon the informant's son with a view to kill him and ultimately he died.

It is submitted by learned counsel for the appellant that appellant has been falsely implicated in this case. There is general and omnibus allegation against the appellant. The allegation of opening fire is against the appellant and other accused persons but the postmortem report of the deceased reveals only one fire arm injury. The appellant has no concern with the alleged occurrence and due to ulterior motive, the appellant has been roped in the present case. The appellant is languishing in judicial custody since 21.10.2022.

The appeal for bail is opposed by learned Spl.



P.P. for the State and submitted that as per postmortem report doctor has opined cause of death due to excessive bleeding due to gun shot injury.

Having heard learned counsel for the parties and taking into consideration that there is general and omnibus allegation against the appellant, the Court is inclined to allow this appeal. Accordingly, the appeal is allowed and the impugned order dated 17.11.2022 is hereby set aside.

The appellant is directed to be enlarged on bail in connection with Amarpur P.S. Case No. 461 of 2022 on furnishing bail bond of Rs. 10,000/- (Rs. ten thousand only) with two sureties of the like amount each to the satisfaction of the learned Additional Sessions Judge-I, Banka.
