The present writ application has been filed for the

purpose of proper investigation in connection with Govindganj P.S. Case No. 393 of 2021 dated 17.12.2021 lodged under Sections 279/ 337/ 338/ 304(A) of the I.P.C. and subsequently, Sections 302/ 34 of the I.P.C. is added.

Counsel for State submits that this case may be disposed off in the light of order passed in *Surendra Singh Vs. The State of Bihar & Ors.* in *Cr. WJC. No. 153 of 2017* and analogous cases decided on 09.09.2022.

In this view of the matter, the present criminal writ petition is **disposed off** with direction to the petitioner to file representation before the Superintendent of Police, East Champaran at Motihari in the light of the order passed in *Surendra Singh Vs.
