4 10-07-2023 Pursuant to earlier order dated 26.06.2023 Mr. Navin Kumar Singh, the Circle Officer, Warisnagar, Samastipur is present in the Court.

2. It is stated that order dated 07.09.2021 passed in C.W.J.C. No. 14934 of 2021 is complied on 27.06.2023. No reasons have been assigned in delaying the process so also there is no application for extension of time in original C.W.J.C. No. 14934 of 2021. Therefore, cost of Rs. 5,000/- is imposed. Cost shall be remitted in Patna High Court Legal Services Committee within a period of four weeks from today.
