4 23-01-2023 Heard learned counsel for the parties concerned.

The contention of the petitioner is that the
Management of Vishnu Sugar Mills Limited, Distt. Gopalganj,



has committed irregularities and has violated the provisions of Sugarcane Act and resolution of the Government.

The grievance of the petitioner is that the number of Weighment Centres, as decided by the respondents, in the locality in the year 2004-05 to 2012-2013 are as follows:-

The petitioner has approached this Court contending that out of seventy one Weighment Centres, only 45-50 persons as Sugarcane Weighment Assistant Clerks, Payment Cashier, Weighment Supervisors are deputed. It has also been contented that the Management has removed the name of the



petitioner from the list of Weighment Clerk in the year 2011-12.
The petitioner has been placed as *Langriman* from Weighment Clerk.

Learned counsel for the State as well as Vishnu Sugar Mills submit that the grievance of the petitioner has been referred to the Labour Commissioner, Chapra, vide Annexure-2 of the counter affidavit.

In the view of the fact that the matter has already been referred to the Labour Commissioner, Chapra, this writ application has got no merit.

Accordingly, this writ application stands dismissed.
