The present writ application has been filed for the

purpose of proper investigation in connection with Kundwa Chainpur P.S. Case No. 172 of 2022 dated 03.09.2022 lodged under Sections 341/ 323/ 389/ 504/ 506/ 385/ 34 of the I.P.C. read with Section 27 of the Arms Act.
