“1.(I) For issuance of a writ in the nature of Mandamus or any other appropriate writ, orders and directions commanding the respondents to remove the encroachment from the road side of Mohalla Dakchin Darwazaa (Narayan Chua) Township P.S. Vishnupad, District-Gaya.

(II) For issuance of a writ in the nature of
