In the said report, it has been stated that the appellant, namely, Indra Narayan Sah (Cr. Appeal (DB) No. 264 of 1996) and Chani Yadav @ Chani Prasad Yadav (Cr. Appeal (DB) No. 365 of 1996) have already died.

Considering the report, sent by the Senior Superintendent of Police, Darbhanga vide its Memo No. 120/Vidhi Shakha dated 23.02.2023 enclosing therewith Memo No. 591/2023 dated 21.02.2023, issued by the Sub Inspector of Police-cum-Officer-in-Charge, Baheri Police
