2 20-06-2023 Heard the parties.

Learned counsel for the petitioners submits that in a land dispute, this case has been filed against the petitioners and the executant of the sale deed is their own grandfather (*Nana*).

If the grandfather wanted to gift some land to the petitioners, he could grandfather wanted to gift some land to the petitioners, he could have executed a gift deed or executed a



will. The entire prosecution seems to be suspicious only to defeat the claim of other co-sharers of the grandfather.

In these circumstances, I am not inclined to entertain this application. It is, accordingly, dismissed.

The trial Court is directed to conclude the trial within six months from the date of receipt/production of a copy of this order.

The accused shall co-operate in this case. If the accused does not co-operate in this case, the Trial Court will take all coercive steps against the petitioners.
