1. The present petition has been filed seeking the following relief :-

*“(i) For issuance of an appropriate writ and/
or order and direction to the respondents to
pass an order on the petitioners’ respective
representation dated 16.07.2014 for granting*



*promotion to the post of Clerk category being
correspondence Clerk from the present post
of Junior Lineman.”*

2. At the outset, the learned counsel for the petitioner seeks liberty on behalf of the petitioner to file appropriate representation before the Managing Director, North Bihar Power Distribution Company Limited, Patna for grant of promotion. Liberty so sought, is granted.
