ORAL ORDER

2 27-06-2023 The present writ petition has been filed seeking the following reliefs:-

“1.A. That this application is being filed for issuance of a writ in the nature of mandamus Commanding and directing the respondents authority to remove the encroachment over the Government land bearing Chak Khata No-124, Chak Khesra No-216, 179, 251, 208, 209 & 233 total area measuring about 68 Decimal, of Muza-Kadipur, situated of village-Kadipur, Kukurha, P.O.-Sisradh. P.S.- Itadhi, District - Buxar, the nature of the said land is "Rasta, Purani



Parti, and the name of the 'Rayat' in the Kathiyan is Anabad Sarve Sadharan Bihar Sarkar & Aam Rasta".

B. Further directing the respondents, to remove the said encroachment by way of comply the order passed by 'Anumandalya Lok Sikayat Niwaran Padhadikaree', Buxar, in Registration Case Number- 530210123032204276 dated 08.06.2022, Ld. 'Anumandalya Lok Sikayat Niwaran Padhadikaree', Buxar, during the course of the hearing of the cases found the encroachment upon the said Road etc, by the anti social elements with the collusion of the government officials for the purpose of personal use, resultant the public road has completely blocked."

At the outset, the learned counsel for the respondent-State, Shri Roy submits that an encroachment case bearing Encroachment Case No.3 of 2022-23, was initiated by the Circle Officer, Itadhi, District-Buxar, whereafter the final order has also been passed, hence the encroachment in question would definitely be removed within a period of four weeks from today.

It is directed accordingly.

The writ petition stands disposed off.
