2 24-11-2023 The present writ petition has been filed seeking the
following relief:-

“1. That this is an application for issuance of appropriate writ(s) order (s) or direction (s) to the respondent No. 4 to pass the final order on the application dated 13.04.2018 submitted by the petitioner against the illegalities committed by the respondents in selection of Respondent No. 7 as Anganwari Sahiyika of Shivo Bahar-II



Anganwari Centre, Centre Code No- 73 within Ward No. 5 of Shivo Bahar Gram Panchayat, Block- Suryapura, District- Rohtas at Sasaram direct the respondents to consider the name of the petitioner for selection to the post of Anganwari Sahayika of Centre Code No. 73 in view of the Guidelines, 2016.”

2. At the outset, the learned counsel for the petitioner seeks a limited direction upon the District Programme Officer, Rohtas at Sasaram i.e. the Respondent No. 4 for disposing off the application filed by the petitioner dated 13.4.2018.

3. Having regard to the limited prayer made by the petitioner in the present writ petition, I deem it fit and proper to direct the Respondent No. 4 to dispose off the aforesaid application, filed by the petitioner, in case the same has not yet been disposed off, by passing a reasoned and a speaking order, in accordance with law, within a period of six weeks of receipt / production of a copy of this order.
