2 27-06-2023 The present writ petition has been filed seeking the following relief:-

“1. That this is an application for issuance of an appropriate writ, order or direction, particularly in the nature of writ of Mandamus, directing and commanding the respondents and its authorities to give approval of Scheme of Atal Vayo Abhyuday Yojana for Senior Citizen under Project No. IP/GAY/00658 in Mobile Medicare Unit Centre (free service) Village: Jhikatiya Kala, P.O: Jhikatiya Kala, P.S: Imamganj District: Gaya for welfare of



beneficiaries/villagers specially which belong to category of beggars/very very poor in application Acknowledgement No. BR/BR/00010536/IPOP/08-20/49025 Financial Year 2020-21, Application Acknowledgement No. BR/BR/00010536/IPOP/05-21/50756 Financial Year 2021-22 and Application Acknowledgement No. BR/BR/00010536/IPOP/02-23/61806 Financial Year 2022-23. (Approval under jurisdiction of State of Bihar).

Further, directing the respondents to issue advance grant under scheme of Atal Vayo Abhyuday Yojana for Senior Citizen in Project ID: IP/GAY/00658 in Mobile Medicare Unit Centre, (Advance Grant under jurisdiction of Union of India).

Further directing the respondent specially State of Bihar to all applications which is pending to send appropriate jurisdiction, Ministry of Social Justice and Empowerment, Government of India”
