Petitioners apprehend arrest in connection with Rafiganj P.S. Case No. 413 of 2022 registered for the offences under Sections 306 and 34 of the Indian Penal Code.

Learned counsel for the petitioners submits that similarly situated co-accused person has already been granted



bail by a co-ordinate Bench of this Court *vide* order dated 07.07.2023 in Cr. Misc. No. 28143 of 2023. Further submission is that petitioners have no criminal antecedent.
