Gan.-02/2022- Sa.Pra. 9077 Patna-15 Dated 06.06.2022, Letter No. 28/Caste Survey-04-01/2022-General Administration-11733 dated 13.07.2022 from Principal Secretary, General Administration Department of Bihar and Letter number-30-76/2022/...../sn dated 28.07.2022 issued by District Collector, Madhepura, Notification Sn 4204 dated 01/03/2023 and Sn 4206 dated 01/03/2023 issued by Secretary to the Government, Notification, Memo No. 28 dated 07.03.2023 s.n. 4713 issued by the Department of General Administration Department, Govt. of Bihar and any other similar notifications until the caste name "BABHAN (BHUMIHAR BRAHMAN)" is restored in "2023 The Bihar Caste Survey".

2. At the outset, the learned counsel for the



petitioners seeks liberty on behalf of the petitioners to approach the State Commission for Upper Caste, or any other Commission as well as the respondent authorities for redressal of their aforesaid grievances. Liberty, so sought, is granted.
