“That this is an application for quashing the order dated 01.02.2016 passed by Sub Divisional Judicial Magistrate, Bhagalpur in Complaint Case No 2071 of 2014 by which he has taken cognizance of the offence under Section 498A of the Indian Penal Code and Section 3/4 of Dowry Prohibition Act.”

Accordingly, dismissed for non-prosecution.
