2. Heard learned counsel for the petitioners and learned counsel for the State.

3. Petitioners’ counsel submits that the case of the instant petitioners is identical to the case of ***Pramod Kumar and Ors. vs. State of Bihar & Ors.*** in ***CWJC No. 13797 of 2016***, in which a judgment has been passed by a Bench of this Court on 03-04-2018.

4. The petitioners are directed to make a



representation before the District Magistrate, Siwan (Respondent No.5) who, on finding similarity between the case of the petitioners and *Pramod Kumar and Ors. vs. State of Bihar & Ors.* in *CWJC No. 13797 of 2016*, shall accord to the petitioners the same benefits and advantages which has been given to Pramod Kumar and Ors. (supra).

5. For the aforesaid purpose, the petitioners will make a representation before the concerned respondent within a period of four weeks from today, which shall be disposed of within a period of eight weeks from the date of receipt/production of a copy of this order.

6. With the aforesaid directions/observations, the writ petition is disposed of.
