APP for the State.

The petitioner has prayed for bail in a case registered  
for the offence punishable under sections 302 of the Indian  
Penal Code.

As per written report of informant chowkidar 2/9  
Jamuna Ram, prosecution story in brief is that he received  
information that one unknown person is being beaten by people  
near Budhi river. On that information the informant reached and  
saw a lot of people gathered and assaulted an unknown person  
knowing child thief and after some times he died.

Learned counsel appearing on behalf of the petitioner  
has submitted that petitioner is innocent and has committed no  
offence. FIR has been registered against unknown. The name of  
the petitioner has been added in this case mere on suspicion as



in a video clip, he was seen at the time and place of occurrence. He was simple a member of the mob. No specific overtact has been alleged against the petitioner. There is no consistent evidence in support of complicity of this petitioner. Similarly situated other accused person has already been enlarged on bail by this Court vide order dated 13.4.2022 passed in Cr. Misc. No. 42377 of 2021. Petitioner has got no criminal antecedent and languishing in judicial custody since 24.1.2023.

The application for bail is opposed by learned APP for the State.

Having heard learned counsel for the parties and considering the facts and circumstances of the case, this court is inclined to enlarge the petitioner on bail. The above named petitioner is directed to be enlarged on bail on furnishing bail bond of Rs. 10,000/- (Rs. ten thousand only) with two sureties of the like amount each to the satisfaction of the learned SDJM, Sadar, Motihari, East Champaran in connection with Pipra P.S. Case No. 310 of 2019.
