3 06-09-2023 Heard the learned counsel for the petitioners and learned APP for the State.

2. The petitioners seek bail in connection with Nawanagar (Basudeva O.P.) P.S. Case No. 407 of 2022 registered for the offence under Sections 147, 148, 149, 341, 323, 504, 307 of the Indian Penal Code and later on added Section 302 of the Indian Penal Code.

3. The deceased and Vinita were assaulted by all the accused persons and in which Vinita sustained three injuries. The petitioners are in judicial custody since 07.01.2023 and



06.01.2023.

4. Learned A.P.P. has vehemently opposed the prayer for bail.

5. In view of the fact that the deceased has sustained one injury that too bruise caused by a hard blunt substance, this application for regular bail is allowed.

6. Let the petitioners, above named, be released on bail *after framing of charge*, on furnishing bail bond of Rs. 10,000/- (Ten Thousand) each with two sureties of the like amount each to the satisfaction of the learned Chief Judicial Magistrate, Buxar, in connection with Nawanagar (Basudeva O.P.) P.S. Case No. 407 of 2022.
