2. Heard Mr. Raghwendra Sharan Pandey with Mr. Somesh Kumar, learned counsel appearing on behalf of the petitioner; Mr. Manoj Kumar Ambastha, learned SC 26 with Tripurari Nath Ambastha, learned AC to SC 26 for the State.

3. Learned counsel appearing on behalf of petitioner submits that petitioner seeks to file a detailed representation for redressal of his grievance before the concerned respondent



in light of the law laid down by the Apex Court in the case of **Uday Pratap Thakur and another Versus the State of Bihar and others** along with other analogous matters, passed on 28.04.2023, reported in **2023 LiveLaw (SC) 371**.
