2. The present application has been filed for quashing the order dated 06.01.2012 passed by the learned Sub Judge-III, Patna in Ex. Case No. 03 of 2009 by which the petition dated 06.08.2011 filed by the petitioner has been rejected.

3. It has been submitted by learned counsel for the petitioner that the Misc. Case No. 16 of 2010 is on the verge of disposal and, therefore, the same may be directed to be dispose of.

4. Learned counsel for the respondents submits that the file has been taken away by the respondents after taking no objection from him.
