ORAL ORDER

2 08-05-2023 The present writ petition has been filed seeking the following relief:-

“1. That this is an application for issuance of writ/writs, order/orders, direction/directions for commanding and directing the respondents to remove the encroachment over the public land (chhath ghat) P.S. No. 105, Khata No. 387, Plot No. 10 area 40 decimals situated in village



Halimpur PS + Circle + Block Sahebganj district, Muzaffarpur registered as "Keshre Hind" plot in Khatiyan and for compliance of the order dated 14.3.2020 passed by the DCLR, Muzaffarpur West in Mutation Appeal No. 127/2018-19 and for other relief / reliefs in the facts and circumstances of the case as enumerated here in after.”

At the outset, the learned counsel for the petitioner seeks liberty on behalf of the petitioner to approach the Circle Officer, Sahebganj, District-Muzaffarpur, for redressal of his aforesaid grievances. Liberty, so sought, is granted.

It is needless to state that in case appropriate representation is filed within a period of two weeks from today, the Circle Officer, Sahebganj, District-Muzaffarpur, shall take appropriate action, in accordance with law the provisions contained in the Bihar Public Land Encroachment Act, 1956, forthwith.

The writ petition stands disposed off on the aforesaid terms.
