ORAL ORDER

3      24-02-2023      1. The petitioner by way of this writ petition has prayed as  
under :-

*“1. That the present writ petition is for  
quashing the order passed by the District Programme  
Officer (Establishment), Gopalganj in Memo No. 2909  
Gopalganj dated 10.08.2022 to Member Secretary, Block  
Teachers Employment Unit-cum Block Development Officer,  
Panchdeori for cancellation of his selection/ appointment/  
candidature under counselling of his selection/  
appointment/ candidature under counselling referring the  
certain irregularities in counselling and enquiry report  
without issuing show-cause and providing reasonable*



*opportunity of hearing, which reveals that the entire exercise was violation of natural justice as on or before the adverse remark/ order; whereas, 'Right of Hearing' is basic and elementary law as well as the further prayer relates with the direction for issuance of formal letter of appointment in terms of Memo No. 136 dated 15.02.2022 issued by the Additional Chief Secretary, Education Department, Govt. of Bihar and give the proper posting and for other necessary relief/reliefs on the basis of the facts and circumstances of the case enumerated stated and discussed hereinafter."*

2. Considering it that this matter is covered by the Judgment dated 23.02.2022, passed in **C.W.J.C. No. 5489 of 2020 (Suresh Ram Vs. The State of Bihar & Ors.)** and connected matters reported in **2022 (2) B.L.J. 381, 2022 (2) P.L.J.R. 80** and the Judgment dated 07.03.2022, passed in **C.W.J.C. No. 34 of 2022 (Minakshi @ Sushre Minakshi & Anr. Vrs. The State of Bihar & Ors.)**, this writ petition is dismissed with liberty to file appeal before the concerned District Appellate Authority.
