2 02-01-2023 Heard learned counsel for the petitioners and learned Ad-
ditional Public Prosecutor for the State.

Petitioners apprehend their arrest in a case registered for
offence punishable u/s 147, 341, 308, 323, 504, 506 IPC.

Allegedly, on account of some altercation, the accused
persons named in F.I.R. including the petitioners abused and as-



saulted the informant and her son. In the mean time, accused Shakti Paswan fired by pistol but it was missed. On gathering the people, all accused persons fled away threatening to kill informant's son.

It is submitted by learned counsel for the petitioners that petitioners are quite innocent and have committed no offence. They have been falsely implicated in this case. No such occurrence, in the manner as alleged, has ever taken place. There is no specific allegation of assault against the petitioners and nobody sustained any injury. It is further submitted that free fight took place between the parties and counter case bearing Khizer-sarai P.S. Case No. 303/2021 has also been lodged earlier by Guddi Devi, wife of accused Deepak Chaudhary against the prosecution side. Petitioners have no criminal antecedent.

Learned APP for the State opposed the prayer for bail.

Having regard to the facts and circumstances of the case, since there is no specific allegation against the petitioners, let the above named petitioners, be released on bail, in the event of their arrest or surrender before the learned Court below within a period of six weeks from today, on furnishing bail bond of Rs. 25,000/- (Rupees Twenty Five Thousand) each with two sureties of the like amount each to the satisfaction of the learned court



below where the case is pending/Successor Court in connection
with Khizarsarai P.S. Case No.304 of 2021, subject to the condi-
tions as laid down under Section 438(2) of the Cr.P.C.
