Additional Chief Secretary/Principal Secretary of the Public Health Engineering Department, Government of Bihar, Patna is hereby directed to appear in person and face the contempt of Court proceedings under Rule 7(i) read with Form 1 of Chapter XXVIII of Rules of the High Court at Patna framed under the Contempt of Courts Act, 1971 (Act 70 of 1971) for non compliance of the order of this Court.

2. Learned counsel for the opposite parties, on instruction, submitted that the petitioner is not co-operating in the department inquiry. Such excuse cannot be appreciated for the reasons that disciplinary authority has every right to proceed with *ex parte* inquiry.
