I have perused the affidavit filed by the Chief Secretary, Govt. of Bihar. From perusal of the affidavit it appears that in exercise of the power under Section 60(1) of the Bihar State Housing Board Act, the Government has authorized Mr. Sunil Kumar Yadav, Additional Secretary, Urban Development & Housing Department, Bihar, Patna to hear Appeal filed before the State Government on behalf of the person aggrieved by an order of the competent authority passed under Section 59 of the Bihar State Housing Board Act.
