2. Learned counsel appearing on behalf of the

Accountant General, Bihar has informed this Court that the

office of the Accountant General, Bihar has received the

sanction letter by the Additional Chief Secretary, Co-operative

Department, however, the communication was made vide Memo

No. 1215 dated 12.05.2023. The delay has been caused by the



Deputy Secretary, Co-operative Society, who has taken nearly four months time to communicate the Accountant General, Bihar, for which the office of the Accountant General, Bihar, is not responsible.

3. Considering the development which has taken place and the fact that office of the Accountant General, Bihar, has already been communicated, the Accountant General, Bihar, is directed to fix the pension of the petitioner and communicate the same to the Treasury Officer of the desired place where the petitioner resides. The Treasury Officer concerned once receives the P.P.O., must send advise immediately within a period of one week so that the entire amount be credited into the pensionary account of the petitioner.

4. Accordingly, the present writ petition is disposed of.
