IV. For direction upon the concerned respondent for not publishing and circulating defamatory notes and statements on their whatsapp group against the Petitioner Firm?

3. Learned counsel for the petitioner submitted that the petitioner has been awarded work on 22.11.2021 and it was stayed by the concerned authority on 13.10.2022.
