ORAL ORDER

2 03-01-2023 The petitioner has an alternative remedy of filing an appeal in terms of the Rules of the Bihar State Teaching Institutions Teachers and Employees (Dispute Redressal & Appeal) Rules 2020. In the judgment dated 23.02.2022 passed in C.W.J.C. No. 5489 of 2020 (Suresh Ram Vrs. The State of Bihar & Ors.) and connected matters **reported**



in 2022 (2) B.L.J., 381 and the judgment dated 07.03.2022 passed in C.W.J.C. No. 34 of 2022 (Minakshi @ Sushre Minakshi & Anr. Vrs. The State of Bihar & Ors.), this Court also held that the writ could not be maintainable in view of the alternative remedy available to the petitioner.

Granting liberty to the petitioner to file remedy as per Rules of the Bihar State Teaching Institutions Teachers and Employees (Dispute Redressal & Appeal) Rules 2020, the writ petition is dismissed.
