2 02-01-2023 Petitioner has prayed for the following relief(s):

“(i) For issuance of a direction to the respondent authority to dispose of the representation filed by the petitioner on 25.05.2019 under section 13(3-A) of the SARFAESI Act which is pending before them for a period of five months.

(ii) For issuance of a direction to the respondent authority not to take possession of factory premises of the petitioner under Section 13(4) of the Securitization and Reconstruction of Financial Assets and Enforcement of Security Interest Act (for short "SARFAESI Act") without disposal of the



representation filed by the petitioner dated 25.05.2019 under section 13(3-A) of the SARFAESI Act.

(iii) For restraining the respondent authorities from taking possession of the petitioner factory premises during the pendency of this writ application or status quo should be maintained.

(iv) For any other relief/reliefs to which the petitioner may be found entitled to in the facts and circumstances of this case.”

Learned counsel for the petitioner seeks permission to withdraw the present petition.

Permission granted.

Present petition stands disposed of as withdrawn.
